
Personal Qualities

About the job

The EV Legal Counsel is the single resource for legal support within the company and as such the role comes with significant autonomy and responsibility. The Legal Counsel works directly with the CEO and is a key member of the 8-person global EV Senior Management team. The Legal Counsel's main responsibilities include reviewing and negotiating MSAs, customer contracts vendor contracts and personnel contracts. This includes ensuring appropriate terms and conditions are negotiated and incorporated into all agreements. The role interfaces with the EV Regional Management teams to provide day-to day legal advice and counsel in commercial and occasionally other areas of the law, including but not limited to, sanctions, intellectual property, commercial, business, employment and insurance, and managing commercial disputes. Additional support may include providing training to Company personnel on contract review, commercial management and reporting, and other assignments, as necessary.







Location

EV is headquartered in Houston, TX, with other offices and operational locations in 36 countries across seven regional teams. The company was founded in the UK which is where all EV's technology development and engineering is located (Norwich, England).
